

CONTRIBUTOR PRIVACY NOTICE

This Privacy Notice ("Notice") provides information on the personal data we collect about you, and how we will use and share your personal data when you provide, or may provide, a contribution to us.

This Notice is for:

- a. Talent who provide contributions to our productions (e.g. actors, musicians, presenters, writers, composers), and other individuals who provide contributions to us (e.g. interviewees or individuals who provide photos or the use of their property for filming purposes) ("**Contributors**"), and
- b. Individuals who are applying to take part in, or who we are in communication with about potentially taking part in, one of our productions ("**Potential Contributors**").

Who collects personal data about you?

TrueLume Films Ltd ("we", "our", "us", "TrueLume Films") is the data 'controller'. This means that we are responsible for deciding how we hold and use certain information about you.

What personal data do we collect about you?

We may collect the following categories of personal data:

Identity Data : Name, previous names, place/date of birth, passport details, ID documents
Contact Data: Email, address, phone numbers, social media handles, emergency
contacts, professional/social profiles
Financial Data : Bank details for reimbursement (if contractually agreed)
Physical Data : Image, voice, photographs, views of your property, other
contribution-related content
Biographical Data: Age, marital status, employment, references, living
arrangements, dependants, relationships, hobbies, personality, opinions, prior TV
appearances, employment and travel history
Special Category Data (where relevant):
 Opinion, Belief and Membership Data: Political opinions,
religious/philosophical beliefs, trade union membership
 Diversity Data: Race, ethnicity, sex life, sexual orientation, gender identity
Criminal Convictions Data: Convictions, proceedings, investigations

We retain personal data only as long as necessary. For contributors, this may be for the duration of a programme's exploitation. Some footage may be retained indefinitely. For potential contributors, data is retained until production is complete unless you consent to longer retention.
